Training: Basic SASL Communication Skills for the ECDOE Staff in the Schools for the Deaf

The service provider is requested to provide South African Sign Language (SASL) training course to the staff employed within the Eastern Cape Department of Education (ECDoE). The training will be conducted in the special schools for the Deaf, namely, Reuben Birin School for the Deaf (Gqeberha) St Thomas School for the Deaf (eQonce) Sive Special School (Cedarville), and the Efata School for the Blind and Deaf (Mthatha)

Target Group

The service provider is expected to submit comprehensive report to the Directorate Inclusive Education and human resources teacher training with the following aspects Organizational commitment behaviors (OCB- All Teaching Staff), SASL Proficiency Levels, School Needs Assessments Language Use and Development.
