The training will be conducted in the special schools for the Deaf, namely, Reuben Birin School for the Deaf (Gqeberha) St Thomas School for the Deaf (eQonce), Sive Special School (Cedarville), and the Efata School for the Blind and Deaf (Mthatha)

- SASL Practical: Educators must be provided with opportunity to practice what they have learned during the training sessions.
- The service provider must provide quality South African Sign Language (SASL) training that will equip hearing educators with communication skills to communicate with and educate deaf learners in South African Sign Language.
- To ensure that South African Sign Language is proficiently used and accessible in schools for the deaf, deaf people and educators will be appointed to schools for the deaf.
- Educators can communicate and educate deaf learners using correct and recognized fingerspelling and the structure of South African Sign Language.
- Educators can interact socially with deaf learners/persons by employing South African Sign Language words to greet, explain, and discuss common themes.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
