1. Application for Appointment as a Marking Moderator in the 2015 to 2017 AET Level 4 Examination ANNEXURE 1.

Read the Instructions on the Application Forms.

NB: All officials are requested to check the Application Forms carefully in order to verify that only competent and qualified AET L4 Educators are appointed to these critically important positions.

Application forms to be handed in at **DISTRICT OFFICES**. AET L4 SBA Coordinators who qualify and have applied as marking moderator/chief marker must also hand in applications to **DCES: EXAMINATIONS** at District Offices.

Verification and sorting will be done at AET Centres at District level by the Verification Committees.

1. **WHO QUALIFIES TO APPLY AS AN AET L4 MARKING MODERATOR OR CHIEF MARKER?**

- All experienced AET L4 Chief Markers, Deputy Chief Markers, Senior Markers and Marking Moderators may apply as AET L4 Chief Markers and Marking Moderators (Attach a copy of Appointment letter and a short CV).
- AET Educators qualify to apply to be AET L4 Marking Moderators or Chief Markers of the AET L4 Examination only if one has taught AET L4 during the period 2011 to 2015 and has been an AET L4 Senior Marker, Marking Moderator or a Deputy Chief Marker in the past 4 years.(2011-2014)
- AET Centre Managers who taught AET L4 during the period 2011 to 2015 and who have a strong support staff that will manage the Centre in their absence.
- AET Educators who have a teaching qualification or an AET Diploma.

2. **WHO DOES NOT QUALIFY FOR MARKING?**

- Office-based educators who are not directly involved in training and supporting of Learning Areas e.g. CESSs, Education Development Officer (EDO), Curriculum Advisors in the GET and FET Phase, must not apply as an AET L4 Marking Moderator or Chief Marker.
- Office-based educators who have never been AET L4 Chief Markers, Deputy Chief Markers, Marking Moderators or Senior Markers in the last 4 years may not apply as AET L4 Marking Moderators or Chief Markers.
- AET Educators who only have a Grade 12 certificate.

3. **VERIFICATION AT AET CENTRE LEVEL:**

- AET Centre Manager to convene a meeting with the applicants and the Centre Management team.
- All application forms must be quality assured jointly at this meeting.
- Complete the LIST OF APPLICANTS that will be signed by each applicant and Centre Manager. The signed attendance register must be attached to this form.(ANNEXURE 2)
- Signing this document confirms that the information contained therein is true.
- AET Centre Manager must present the list of applicants to the whole staff before he/she appends his /her signature.
- Any false information on this document will result in the blacklisting of the whole centre for two years.

4. **INSTRUCTIONS TO AET CENTRE MANAGERS**

- Approval must only be given by signing the form if the educator was/is responsible for teaching the Learning Area in AET L4 during the period 2011-2014.



- Centre Managers must not sign application forms of AET Educators who are not teaching in their centre.
- As Manager of the AET Centre, do not sign your own application form. This form must be signed by the District AET SBA Co-ordinator.

NB: Centre Managers must ensure that information provided on application forms is accurate and verifiable.

5. VERIFICATION AT DISTRICT LEVEL:

5.1 The members of the Verification Committee to consider the application forms for AET L4 Marking Moderators/ Chief Markers will include:

- CES: Curriculum (Chairperson)
- CES: Governance
- DCES: Assessment and Examinations
- Education Development Officer (EDO)
- Teacher Union representatives as observers

NB: The committee must ensure that all criteria are met and information provided is verified. Reasons must be written in the space provided on the application form in the event of rejection.

5.2 The members of the Verification Committee to consider the application forms for AET SBA Co-ordinators who apply as AET L4 Marking Moderators/Chief Markers will include:

- CES: Curriculum (Chairperson)
- CES: Governance
- DCES: Examinations
- Education Development Officer (EDO)
- District AET officials
- Teacher Union representatives as observers

NB: In the Districts where there are appointed AET DCESs and SESs, preference must be given to the SESs.

5.3 The membership of the Provincial Committee that appoints the AET L4 Marking Moderators/Chief Markers is:

- Director Assessment & Examinations
- Provincial AET L4 Curriculum Coordinator
- Provincial CES & DCES Marking Processes
- Teacher Union representatives as observers



6. **CONDITIONS FOR APPOINTMENT**

- Appointed AET L4 Marking Moderators/Chief Markers must have attended all professional development and training programmes and have a proven track record of excellence in the Learning Area applying for.

7. **CRITERIA FOR REJECTION OF APPLICATIONS:**

- Incomplete or illegible applications will not be considered.
- Application forms received at the District Office after the due date will not be considered.
- No application forms will be accepted at the Provincial Office. All applications must come through the District Office and be verified at District level.

8. **IMPORTANT DATES:**

- Closing date for application forms at the District: **17 July 2015.**
- Closing date for submission of application forms at the Provincial Offices: **24 July 2015.**

Kindly note that all the information provided in application forms will be **verified** with the **database** in the **Provincial Office** as well as with **EMIS**. Applicants are therefore reminded that provision of inaccurate and fraudulent information constitutes grounds for immediate disciplinary action and disqualification. In particular, Centre Managers and Chairpersons of Verification Committees are cautioned not to append their signatures if all criteria are not met.

The co-operation of all education stakeholders in this important process is both anticipated and appreciated.

EXTRACT FROM GOVERNMENT GAZETTE, 5 JULY 2002 [No. 23590 Page 27]

The criteria to qualify for appointment as an AET marker (including senior marker, deputy chief marker and chief marker) should include the following:

- (1) A recognised three year teacher qualification or a recognized AET Tutor's Certificate.
- (2) Appropriate teaching experience, in the Learning Area concerned, at Level 4.
- (3) Learning Area competency.
- (4) In addition to the above criteria, preference should be given to serving AET educators who are presently teaching.

- When a tutor's application has been approved, the tutor must sign next to his/her name.
- The Centre Manager must append his/her signature next to the name of the tutor he/she supervises.
- The List of Applicants must be presented to the whole staff.
- The Centre Manager signs the List of Applicants, after the staff has accepted that the applicants taught AET L4 during the period 2011 to 2015.
- The Centre Manager must submit the list to the District Office, and sign for it on submission.
